- There are 50+ booth spaces available to be reserved. Priority & early registration given to current Healthy Planet advertisers & past exhibitors. A current advertiser is any client who has a display ad running for at least three months in 2019.
  - The Expo will run from 10am to 4pm. Exhibitors can begin setting up at 8:30am. Breakdown is from 4-5:00pm.
  - Each exhibitor will receive an 8' x 30" table and two chairs. Additional chairs are available on a first-come, first-served basis. Booth spaces are approximately 8' x 7'. Pipe and drape will run behind non-wall space booths to hang banners, etc. Exhibitors must supply table covering, etc.
  - Public admission fee will be \$8.00. Exhibitors receive a minimum of 30 FREE PASSES for clients, customers, family and friends. (\$240 Value)
  - We will publicize the Expo in *The Healthy Planet*, local publications and/or radio/tv prior to the event. Exhibitors will be listed in the March 2019 edition of *The Healthy Planet* if registration form and payment has been received by publication deadline date of Feb. 15, 2019.
  - **No reservation is complete until payment received.** Cancellations up to 48 hrs. of event = 50% refund. No refund for no shows day of expo.
  - Confirmation with free passes will be sent via email approximately 2-3 weeks prior to the Expo.
